- I. The scholarship supports undergraduate programs, master's programs, doctoral programs, general scholar programs and senior scholar programs in variety of Chinese colleges and universities.
- II. Candidates sponsored by the scholarship will start the programs from 2025-2026 school year.
- III. **The scholarship covers tuition, accommodation, subsidy and comprehensive medical insurance during study in China without coverage of international travel expenses.**
- IV. Eligibility of applicants for the scholarship includes:-
  - be a citizen of a country other than the People's Republic of China.
  - be in good health and with none of infectious diseases or diseases endangering public safety.
  - with good academic performance and well-behaved during study or work and with language capacity in Chinese or English to complete the program.
  - be not sponsored by any other Chinese scholarships from local governments, colleges or universities.
  - be a high school graduate under **the age of 25** when applying for **undergraduate programs**.
  - be a bachelor's degree holder under **the age of 35** when applying for **master's programs**.
  - be a master's degree holder under **the age of 40** when applying for **doctoral programs**.
  - be a high school graduate (at least) under **the age of 45** when applying for **general scholar programs**.
  - be a master's degree holder or an associate professor (or above) under **the age of 50** when applying for **senior scholar programs**.

The nominations of candidates should be submitted to the General Secretariat of the OIC no later than end of January 2025 for onward transmission to the Chinese authorities.
